### **Occupational Course of Study Update**

On February 3, 2021, the State Board of Education voted and approved the revision of the Occupational Preparation courses: Employment Preparation I – IV. The Employment Preparation courses should be taught in sequential order as the content is designed to help the student build skills and increase their depth of knowledge over the grades 9-12. These courses and their requirements apply to students <u>entering the 9<sup>th</sup> grade for the first time in 2021-2022</u> and are contained in Section II of the <u>GRAD-004</u> Policy.

Summary of <u>Occupational Course of Study</u> (OCS) credits needed for graduation:

- 4 English (ELA)
- 4 Math (includes Employment Prep IV Math)
- 3 Science (includes Employment Prep I Science)
- 4 Social Studies (includes Civic Literacy & Employment Prep II 1A & 1B)
- 1 Health & PE
- 4 CTE Electives Credits
- 2 Additional Employment Prep Citizenship III 2A & 2B and 600 work hours
- Career Portfolio
- Completion of IEP Objectives
- Legislative Requirement: CPR

On March 3, 2021, the State Board of Education voted and approved the following for the *graduating class of 2021*:

- Waived the CPR graduation requirement
- For OCS students, reduced the graduation requirement of paid employment to 157 hours.
