Direct instruction programs will be purchased and staff will be trained in their implementation. Our MTSS PLC will involve reviewing/analyzing student data. A systematic process to move students through the Tier process and Direct Instruction program will be implemented. This school year (2018-19) we are planning to increase our Tier 3 intervention times for grades 3-5 and continue with the same direct instruction programs.
