Section 17 - All appropriations shall be paid first from revenue restricted as to use, and second from general unrestricted revenues.

Section 18 - The superintendent is hereby authorized to transfer appropriations within a fund under the conditions as follows:

- a. He may transfer amounts between sub-functions and objects of expenditures within a function without limitations and without a report to the board of education being required.
- b. He may transfer amounts not to exceed \$50,000 between functions of the same fund with a report on such transfers being required at the next meeting of the board of education.
- c. He may not transfer any amounts between funds.

Section 19 - Copies of the Budget Resolution shall be immediately furnished to the superintendent and school finance officer for direction in carrying out their duties.
